### **Prayer**

We desire to reach the emerging generations through a summer intern experience that will involve the CEO and/or executive leadership team of an FCCI membership company. We pray that through this experience, college students will become more aware and spiritually mature about marketplace ministry and their calling.

We know that 87 percent of businesses in a recent survey believe that college graduates are ill-equipped for work. One of the reasons may be their worldview.

### **Vision**

To develop college students to be lifetime laborers who are committed to following Jesus and multiplying disciple-makers in their workplaces and communities through a specialized summer internship program focused on:

- Interning with the CEO or Executive Leader of an FCCI company
- Training in leadership, integrity, and leading a company for Christ
- Vision for spiritual multiplication through the marketplace and community
- Experiencing ministry in the marketplace, community and nation
- Practical experience in strategic plan development impacting the company and/or community
- Intern will participate in the Business Leadership Group during the summer months
- FCCI International or Regional Conference experience through Livestream
- Invite Only

### **Goal**

One Million FCCI Interns in the next 20 years

### **Hiring and Placement of Interns**

FCCI will accept students who have completed their first year of college courses and be student leaders in their respective college or university.

Internship application, resume and \$25 application fee must be received at application.

Process: FCCI will provide a student information page online at [fellows.fcci.org](http://fellows.fcci.org) for FCCI member companies to view and select candidates for phone interview.

- The FCCI membership company should post their job no later than January 8, 2016.
- The FCCI membership company should conduct the first Phone interview no later than February 29, 2016.
- The FCCI membership company will accept or deny applicant to continue on to stage two within two weeks.
- The FCCI membership company will conduct its second and final interview by phone or in person.
- The FCCI membership company will make its selection of student no later than March 31, 2016.

### **Details of Employment and Finances**

1. Weekly work hours set by the respective FCCI membership company
2. Participation in an FCCI weekly business leadership group is recommended, if available
3. At least one weekly peer-on-peer discipleship meeting with the CEO and/or Executive Leadership
4. FCCI resources are recommended for development of the student
5. Paid internships: Employer determines the wage salary and pays through employer's payroll
6. Ten weeks in scope, ideally ending August 1st
7. Consider a \$100 tax-deductible gift to FCCI to cover the students Livestream conference experience
8. Intern should be challenged by a major project that will impact the business and/or community
